Sir / Madam,

1- In context to subject cited above I am directed to inform you that as per provision u/s 73 of MUHS Act 1998 and as per the decision of the Academic Council taken in its meeting held on 23/09/2025 vide Resolution No. 386/2025, it was decided to permanently disaffiliate the Prakashchand Jain Ayurved College, Palaskhede, Jamner, Jalgaon from the Academic Year 2025-26 .

However, as per interim relief granted by Hon'ble High Court, (Aurangabad bench) against W.P. 11969, dt. 29/09/2025 it is decided to grant "Part Continuation/ Extension of Affiliation" only for second year & Third year of B.A.M.S. (as applicable) to your college for the Academic Year 2025-26, subject to final outcome of the said writ petition and as per following conditions:-

- The part affiliation is subject to outcome of the W.P. no. 11969 filed by the college.
- This "Part Continuation/ Extension of Affiliation" shall not affect the decision of the university regarding permanent disaffiliation of the college from Academic Year 2025-26.
- The intake capacity shall be treated as 60 for the purpose of various academic activities other than student's admissions for First year BAMS as the college has been included in the ambit of Prakashchand Jain Ayurved College, Palaskhede, Jamner, Jalgaon.
- Grant of permission from Govt. of India, Ministry of Health & Family Welfare, Department of AYUSH/Central Council and /State Government (as applicable).
- Fulfillment of all deficiencies and submission of its compliance report within Three Months from the date of issuance of this letter.

2. Since it is decided to grant "Part Continuation of Affiliation" for the Second year and Third year (as applicable) of UG BAMS Course in the A.Y. 2025-26, you are therefore requested to ensure that no admission shall be made to the 1<sup>st</sup> Year BAMS (UG) course for the A.Y. 2025-26 in your college under MUHS. Strictly observe the same under intimation to this University.

3. You are requested to comply with the previously communicated deficiencies within a stipulated time without fail and submit compliance report.

4. Kindly note the above and do the needful.
